President's Message

Janet Albers, MD

Implementation and humbled to serve you as President of the Illinois Academy of Family Physicians over the next year. I graduated from Southern Illinois University School of Medicine in 1987 in a class of 72 students where HALF entered the field of Family Medicine. Now in my 25th year of practice after completing residency, I am still as passionate about Family Medicine as ever.

I have spent time as part of a small group practice and also in a multispecialty group. I gained skills and experience in caring for patients. But it was when I became a residency faculty at SIU in 1997 that I finally pulled together my love of caring for patients and a love of teaching students and residents. Serving as a program director for 15 years and now in my role as Chair of the Department of Family and Community Medicine at SIU, I see the impact we can make by teaching future family physicians.

My role in the Department of FCM at SIU includes oversight of the four regional residency programs in Springfield, Decatur, Quincy and Carbondale. Two sites are rural health clinics, one is a federally qualified health center. All four residency sites are NCQA-designated Patient Centered Medical Homes dedicated to continuous comprehensive care of patients through interdisciplinary teams focused on quality outcomes, providing integrated/ enabling services and preparing the primary care workforce of tomorrow. Kind of sounds like the family medicine dream, doesn't it?

In reflecting on these past 25 years, I am struck by the tremendous changes



that family medicine has witnessed. The system of medicine became more complex – more high tech – more expensive – but with poorer outcomes. We saw too many people falling through the cracks in a disjointed system which was hard for them to understand and navigate.

But – the Future of Family Medicine provided a roadmap and enabled us to transform ourselves – to meet the needs of our patients and communities. Now we are talking about healthy communities and working together with a diverse interdisciplinary team- nurses, PAs and NPs, midwives, pharmacists, care coordinators and behaviorists. We are also partnering with our patients. Working with the hospitals and community agencies to improve overall population health. We are working to bridge the health literacy gap between patients' understanding of the medical system and managing their medical care.

By improving our ability to communicate our health care recommendations, we improve our patients' ability to follow them and succeed. We strive to be sensitive to the patients' values and desires. We support them in accomplishing their health care goals. Now with The Future of Family Medicine 2.0, we know that Health is Primary, and we family physicians are key to America's health. IAFP is the tool allowing me to partner with 4,500

family physicians in Illinois and 115,000 across the U.S. in various practice settings all dedicated to our common vision of family medicine in meeting health care needs and supporting each other - through practice enhancement, education, health of the public and advocacy.

My primary goal this year will be to listen to your needs and concerns and work to represent you and our patients' best interest. My second focus, as an educator, will be to bring attention to primary care workforce issues. We are presently about 30% of the workforce, but with the number of U.S. students choosing family medicine in recent years, our trajectory is headed towards 18%. We need to alter the course. As an action item for this goal, I will be personally encouraging SIU students and residents to participate in the 2015 IAFP Spring into Action lobby days in April. And I'll be there to give them the knowledge, the confidence and the VOICE to speak up for patients and for family medicine in Springfield.

I also look forward to our May 2015 board meeting in Washington, DC where your IAFP board will unite with members from around the country at the Family Medicine Congressional Conference to advocate directly to Congress for our members. I challenge you over the next year to inspire and recruit one student to join us in family medicine. You can recruit a patient, neighbor, or friend-whether in med school, high school or even younger. Share with them the JOY in family medicine that drives you to work each day.

Perhaps one day soon we will have graduating classes like mine in 1987, where half of the students enter family medicine-ready to meet the future of health care.

Advocacy

Illinois now has a plan for statewide impact through coordinated healthcare across private and public funding and delivery mechanisms, called the *Alliance for Health*. Family physicians provide advice, information and counsel all along the way.

Academy Report

Devoted to Action

\$1.4 billion in savings through the Patient Centered Medical Home in Illinois Medicaid, 2007-2010, was documented by AAFP Graham Center in September/October *Annals of Family Medicine*, http://www.annfammed.org/content/12/5/408. abstract IAFP leaders led Your Healthcare Plus (Carrie Nelson, MD and Fredric "Rick" Leary, MD) and Illinois Health Connect (Margaret Kirkegaard, MD) during the years of the study. Illinois Medicaid has moved to "care coordination" covering 50% of Medicaid patients by the end of 2014. Alvia Siddiqi, MD, IAFP president-elect provides leadership and oversight for providers and Medicaid clients in her role at Illinois Health Connect, which provides direct support to 500,000 patients in primary care case management and indirect support to 250,000 more patients who are enrolled in Accountable Care Entities (ACEs) and Coordinated Care Entities (CCEs).

IAFP has **local impact** in one of the largest cities in the U.S. when AAFP and IAFP met with Chicago Dept. of Health about *Healthy Chicago* the blueprint to make Chicago the healthiest city in the nation. AAFP (Julie Wood, MD, Vice President of Professional Affairs and Javette Orgain, MD, MPH, Vice Speaker) and IAFP leaders (Carolyn Lopez, MD, and Vince Keenan, MSPH, Executive Vice President) met with Commissioner Bechara Choucair, MD, MPH, a family physician, to make sure IAFP and family medicine are a strong part of that agenda.

Building **federal impact** through AAFP FamMedPAC: Illinois ranks 3rdth among chapters in 2013-14 contributions to FamMedPAC with over \$35,000 in donations from 118 members. Donations were then made from the PAC to six Illinois Representatives and one Senator, totaled \$37,000.

Illinois has **impact at the AAFP level** through the AAFP Congress of Delegates and AAFP Commissions: Javette Orgain, MD, MPH, of Chicago, was re-elected to a fourth term as AAFP Vice Speaker at the AAFP Congress in Washington, DC. David Hagan, MD, of Gibson City, ran a splendid campaign for AAFP board director but was not elected.

Illinois Resolutions to restrict raw milk distribution and one to add Tdap to the Medicare Part B coverage were issues IAFP brought to the AAFP Congress and both successfully passed.

Family physicians deliberated resolutions on: Raw milk distribution; an exemption to the Age Discrimination Employment Act to screen physicians for dementia; polling IAFP members about "single payer" and requiring health plans to report benchmark quality indicators and progress. The Academy will be following through on these in 2015. You can see the full resolutions on our new web site. Janet Albers, MD, of Springfield was installed as the 67th Academy president along with new officers and board directors, who were elected by electronic vote of Active and Life members. Quality Improvement – Impacting your patients

Quality improvement (QI) is the basis for measuring clinical performance. IAFP concluded its three-year Practice Improvement Network in 2014, helping practices with fiscal and clinical practice improvement as they moved along the Patient Centered Medical Home continuum. IAFP continues to work with other organizations (such as Illinois Chapter American Academy of Pediatrics) to make sure QI activities offered also counted for ABFM Part 4, performance-in-practice requirements.

Practice Transformation You Academy understands the challenges. AAFP offers many practice transformation products and services to help all family physicians. We have joined forces with Illinois Chapter American Academy of Pediatrics to offer health systems practice transformation education, technical assistance, clinical education and assistance with board recertification requirements.

Taking action to secure our specialty and impact the future

Get to know Family Medicine for America's Health - Launched at the AAFP annual meeting in October, Family Medicine for America's Health is a three-year communications campaign and a five-year strategy campaign to change the payment mechanisms for medicine to support practice transformation and family medicine/primary care. The public awareness movement is called "Health is Primary." If you haven't seen it yet, get to www.healthisprimary.org and get on board.

Illinois has two members on the FMAH board: Jerry Kruse, MD, MSPH, CEO of SIU Health Care and Vince Keenan, MSPH, CAE, IAFP's chapter executive. Stanley Borg, D.O., of Chicago serves on the Payment strategy team.

Teaming up to impact outcomes. Team work is the solution in clinical practice; and likewise your Academy teams up with organizations across Illinois to provide education, advocate family medicine positions, launch new endeavors, and bring you new products and services to help clinical practice.

- **Behavioral Health Integration** bringing primary care into behavioral health settings and vice versa, Illinois Psychiatric Society and IAFP are exploring best practices and supporting innovations such as the three summits held in 2014 by the Illinois Department of Human Services on the use of the SBIRT (Screening, Brief Intervention, Referral and Treatment) intervention. The IAFP's committee on Clincally Integrated Networks continues to lead our work in this arena.
- **Choosing Wisely** will ensure the right care at the right time with the hallmark patient-physician relationship at the center of decision-making. IAFP co-sponsored a conference in November hosted by Midwest Business Group on Health. Working along with the Illinois Hospital Association, physician groups can deliver on the potential of Choosing Wisely. Learn more at www.choosingwisely.org.
- Vaccinate Illinois Week gets the word out in early December that getting a flu shot is healthy, safe and a high priority. Organized by Chicago Department of Public Health and Illinois Department of Public Health, this third annual event included clinical education by IAFP and other health organization partners, and widespread public relations activities.

More Action behind the scenes

IAFP enlisted the "Nifty Nine" focus group in 2014. Nine members from various practice demographics volunteered to attend IAFP activities, review IAFP publications and participate in a live focus group after the annual meeting in 2014. Their work and feedback will help our staff and leadership work to shape Academy activities and services to meet your needs across the career spectrum.

Two new committees have been formed to further family medicine interests.

- 1. New family physicians (those in practice seven years or less after completing residency) and
- 2. Family physicians at federally qualified health centers (FQHCs).

These activities fuel the changes of how IAFP communicates with you, and how we try to engage you, and serve your needs.

Devoted to Student and Resident Activity

IAFP's Foundation is the home of the newly formed Family Medicine Midwest Foundation, uniting our region in a common mission of building the family medicine workforce for our future. The Family Medicine Midwest annual conference is a three-day event with these goals:

- Attract and inspire medical students to choose Midwest Family Medicine Residency Programs
- Provide a format for residents to present, to learn from each other and from faculty presenters, and find their family medicine career path
- Showcase the amazing variety of career opportunities in family medicine
- Provide a platform to share innovative ideas, best practices and build regional networks dedicated to improving the health of all patients.

IAFP's Government Relations Committee and Legislative Action Team work in tandem with staff and our contracted lobbying firm of Cook-Witter, Inc. to steer the Academy's activities and maintain solid relationships with lawmakers at all levels in both parties.

As a respected voice in government affairs, IAFP represents the interests of family medicine on a wide array of issues and work to improve the many environments where family physicians practice. Our breadth and scope of advocacy mirrors YOUR breadth and scope in practice.

Devoted to Advocacy

We support policies to strengthen primary care and have worked to:

- Convey the accurate value of primary care services in both the government and private sector
- Increase the role family medicine has in improving both the efficiency and quality of care.

While you were seeing patients, managing your practice and earning your continuing medical education credit, we worked with the 98th Illinois General Assembly – here are some highlights:

- Tracked approximately 300 healthcare bills that would impact family medicine
- Protected and extended the Medical Practice Act
- Continued to fight for primary care services to your patients
- Supported Medicaid reform to preserve and strengthen a program providing care to 3.1 million Illinois patients
- Lobbied to keep the Illinois Poison Control Center open and effective
- Participated in streamlining the Physician Orders for Life Sustaining Treatment (POLST) DNR form, which is designed to help patients and families plan for their care in the last year of life
- Opposed scope of practice efforts that would lead to a tiered delivery system which would deny the best care to all patients by a qualified physician
- Collaborated with business, consumer advocates and health systems in support of quality outcomes that every patient deserves, to quality data that a patient-centered medical home delivers
- Advocated as the lead physician voice in the fight for Smoke-free Illinois, higher tobacco taxes and public policies aimed at reducing tobacco use across the spectrum, including landmark e-cigarette regulations

Speaking up for smart care in Springfield

In April, then president-elect Janet Albers, MD testified against mandated Hepatitis C screening in a subject matter hearing of the Senate Public Health Committee. While the bill was not voted on, IAFP will continue its work to educate legislators about HepC screening. Meanwhile the Centers for Medicare and Medicaid Services announced it will reimburse for hepatitis C virus screenings for two target populations. The coverage determination brings Medicare into alignment with private insurers. CMS will only reimburse for screening for beneficiaries who fall into two categories:

- 1. Individuals who are considered at high risk for the disease, including individuals who have a current or past history of illicit injection drug use or those who had received a blood transfusion prior to 1992.
- 2. Individuals who were born from 1945-1965. About two-thirds of patients with hepatitis C were born between these years, according to the U.S. Preventive Services Task Force.

On the Hill in Washington, DC. IAFP leaders used the AAFP Family Medicine Congressional Conference to advocate for physician payment reform and Graduate Medical Education funding. Also that week, Deborah Edberg, MD, IAFP second vice president, testified before a Senate Committee on Health, Labor, Education, and Pensions Subcommittee about the success of her Northwestern McGaw Family Medicine Residency program as a model for community-based physician training, advocating for continued funding for Teaching Health Centers.

Elections produce a shift in Illinois Leadership

Illinois elected a Republican Governor for the first time since 2003. Bruce Rauner won the November 4th General Election and will work alongside the following Constitutional Officers: Incumbents Attorney General Lisa Madigan (D) and Secretary of State Jesse White (D). Due to the untimely passing of Comptroller Judy Baar Topinka (R), Leslie Munger was appointed by Gov. Rauner to serve. In addition, State Senator Mike Frerichs (D) was ultimately declared the winner in a very tight race for State Treasurer.

In the Illinois Senate, 19 of 59 seats were up for election and only seven of those seats were contested. Republicans gained one seat with the election of Neil Anderson, a firefighter and paramedic from Moline. He will join Senator Chris Nybo (R-24, Elmhurst) who was appointed to replace Senator Kirk Dillard (R) as two new faces in the Senate. The Senate Democratic caucus will still have a veto-proof supermajority. On the House side, all 118 seats were up for election, 70 with no opposition. Of the 48 contested races, all Democrat incumbents were re-elected, allowing Speaker Madigan to maintain his veto proof majority in the House.

At the federal level, Senator Richard Durbin (D) was re-elected to the United State Senate, but with Republicans taking the majority, he will no longer be the Senate Majority Whip. The Illinois Delegation will gain two Republican

seats with Robert Dold (R) reclaiming the 10th Congressional District and Mike Bost (R) defeating incumbent Bill Enyart (D) in the 12th District. The Illinois delegation is now ten Democrats and eight Republicans.

Action in Springfield and Capitol Hill. IAFP returns to Springfield for Spring into Action, three days of education and lobbying at the statehouse. The IAFP Board of Directors will attend the AAFP Family Medicine Congressional Conference in May to bring Illinois concerns to Congress.

Representation on boards, task forces and initiatives – IAFP staff and seasoned leaders represent you on the State Board of Health, in state and local government posts, coalitions, task forces and committees making decisions that affect physicians and patients. Through our work, YOU have a seat at every table.

Annual Meeting

IAFP took the meeting to Key Lime Cove Water Park last November in Gurnee. The meeting offered 3 SAMs workshops to help physicians complete part II of the ABFM MoC along with 18 educational programs for a total of 12.50 CME credits. Kathleen Klink, MD from the Robert Graham Center kicked the meeting off with her plenary session on "Family Medicine and Primary Care: The Promise and the Challenge in the Era of Health Report" presentation. Attendees also enjoyed a mixture of hour-long presentations and thirty-minute presentations on a variety of timely topics including an Eloba Update, Sports Medicine, Medical Marijuana, Intimate Partner Violence, STDs, Dermatology and the Flu Vaccine. A new format allowed residents and students to take the stage for the "2

minutes, 2 slides, 2 questions" concept to present an interesting case they encountered.

Family Medicine Midwest CME Sessions

For the third consecutive year, the Family Medicine Midwest conference provided top-notch educational programming. The three day event provided up to 12 CME credits through a wide variety of sessions. The two poster sessions in a busy central location gave the student and resident presenters a great opportunity to showcase their work. Three diverse plenary sessions showcased the role of the arts and humanities with the Hippocrates Café, allowed for students and residents to hear multiple experts speak on their specialties during the Speed Date Your Specialty luncheon, and featured David Moen, MD as the closing plenary speaker on "Delivering New Value for High Risk Patients and Their Families."

Immunization Awareness Initiative

The Academy continued the Flu Vaccine Awareness campaign in 2014, thanks to a grant from the Illinois Department of Public Health. Two brochures (Influenza Vaccine for Individuals with Diabetes and Influenza Vaccine for Individuals with Asthma) and a poster were once again available for members to order for their practice.

Partnering again with IDPH, IAFP was pleased to expand the Immunization Awareness campaign to include the Human Papilloma Virus and Meningococcal vaccines. Two new brochures will be available for members to order and use in their practices in early 2015!







Safe Prescriber Program

IAFP unveiled a new three-level Safe Prescriber Program in Spring of 2014.

- 1. Level One status requires physicians to enroll in the Illinois Prescription Monitoring Program (PMP) in order to receive a certificate indicating they are a Level One Safe Prescriber.
- 2. Level Two, physicians must successfully complete the newly updated Pain Management online CME, develop an office policy for controlled substances, and utilize a patient contract. Level Two Safe Prescriber physicians receive a Safe Prescriber lapel pin and recognition at the IAFP Annual Meeting.
- 3. Level Three Safe Prescriber status is coming soon and will involve a Quality Improvement (QI) project that can be used towards Maintenance of Certification (MC-FP). After completing Level Three, physicians are eligible to receive a press release for their local paper and a recognition reception at their practice.

Lunch & Learn Webinars

The Lunch and Learn webinar series brings free, quality CME programs to IAFP members monthly during lunchtime! The 2014 series included Concussion Management Updates – Best Practices for 2014, Immunizing Adolescents Against HPV and Meningococcal Disease, Geriatrics Under Medicare, and Primary Palliative Care – What's In It for My Practice? Through these (and other) webinars, physicians were able to obtain CME while hearing the latest updates on issues that face the many diverse types of patients they see in their practices.



The Finance Committee was chaired by then-Treasurer Ravi Grivois-Shah, MD and its charge is to ensure the integrity of the fiscal affairs of the Academy, including overseeing budget development and regular financial reporting. IAFP has an annual audit of its financials and the auditors have not brought any concerns to the Finance committee or Board regarding any aspects of the audit. The Academy has an Audit **Task Force** to review the audit as well as the annual tax return.

IAFP earns its revenue from member dues (50%), education projects (39%), meeting sponsorship and registration (8%), publication ads (2%) and member services (1%).
