President's Message

It's been a long and winding road for me to become the current President of the IAFP. I took the Oath of President at the IAFP Annual Meeting on November 12, 2016 and shared my story with those members gathered in Naperville. I'd like to share an abbreviated version of my story and my goals for this year with you in my first President's Message.

It wasn't easy for my parents, Jerome and Mirka Lurye from Day 1; I was a mid-forceps delivery under general anesthesia followed by a seven-day inpatient stay with my mother. There was no problem – in 1953, that was a normal birth! I survived, and then thrived, channeling my inner nerd through college and medical school. Since completing family medicine residency training at the University of Maryland, my career has taken me on a multi-state journey that includes:

- Solo practice in rural North Carolina
- Small group, urgent care and multispecialty practice and early group leadership experience in the Atlanta, GA area
- Chief Medical Officer and part time practice in a multi-specialty group in Evansville. Indiana
- And now the CEO of Elmhurst Clinic in the western suburbs of Chicago since 2008. Our group has grown to 113 physicians and other professionals, including 14 family physicians with plans to add even more.

Though it's been a while since I've provided direct patient care, it is a huge part of my professional history, which I bring to my current administrative position and to my role as IAFP's president.

In order to further our mission "to promote excellence in the health and well-being of the people of Illinois



through support and education of family physicians and the families and communities they serve," I plan to focus on the support of our members by encouraging member interest groups.

Our membership is varied in location, age, patient population, practice size, ownership, and structure. Can we connect members of similar interests, successes or challenges to collaborate and problem solve together? The Direct Primary Care member interest group is a great example of a practicebased interest group, while the Women in Leadership interest group unites women physicians from across the career spectrum and across the state to share challenges, success stories, ideas and inspiration. Look at them online and join the one that matches your family medicine priorities or expertise! Are there other communities that could form organically and operate? We have a community forums platform within our www.iafp.com website where members can join, communicate and collaborate in a secure messaging system without clogging up your already overflowing e-mail inbox.

Education is a critical service that IAFP provides for our members in a variety of channels. Our CME committee works to ensure high-quality CME that meets your needs. Some upcoming live options are the Chicago Essential Evidence conference and the Springfield Essential Evidence conference, both in March. IAFP provides monthly lunch

and learn webinars, along with our enduring CME modules on our cme.iafp.com platform. We're also in the business of helping you navigate the ABFM Maintenance of Certification process; you can KSA with IAFP!

Advocacy is always at the heart of the Academy's mission. I am proud to hear IAFP called an "advocacy organization" rather than solely a "physician society." We advocate for our specialty, our members and our patients, at the local, state and federal level – with payers, policymakers and with the public. The advocacy landscape changes in 2017 with new faces in the Illinois General Assembly, a few shifts in our Illinois Congressional delegation and another Donald as president of the United States. It is time to reintroduce ourselves. We can start with the IAFP Spring into Action lobby days in Springfield May 9, 10 and 11. Take one day away and join us. We must define family medicine and the principles that we stand for; access to health care, value of primary care physicians, comprehensive and community-based care, reducing administrative burdens, and building a bigger, stronger and more diverse family medicine workforce.

We must also strengthen our current workforce. I have seen evidence that burnout is a concern for our members across the career spectrum, from medical school up until the final years of practice. In fact, some physicians are leaving medicine earlier than planned. We must continue to address the issues that are causing burnout, while also ensuring that we take care of ourselves. I urge you all to make time for something outside of medicine that also makes you who you are. For me it's playing the clarinet, personal fitness and family time. For others it may be travel, dance, hiking or coaching their children's basketball team. Whatever it is, keep it on your schedule.

Like the family physicians we serve, IAFP continues to work on issues that impact the big picture for our members and their patients. Academy Report

IAFP and family medicine impact health care with...

- Expert family physician leaders who are shaping the future of our health care system

- Dedication to Advocacy, Education and Action and a commitment to all three of these approaches on the issues that matter to you, your practice team and your patients.

Serving the under-served: IAFP members are the backbone of our state's primary care clinics to the underserved, the FQHCs and rural health clinics. Our members train there, work there, and teach there. Their dedication leads to changes and innovations to improve the health of our most vulnerable. They care for the sickest of the sick, the depressed, the addicted, the homeless, the victims of violence, the medically complex and challenging cases. IAFP's FPs in FQHCs committee has worked to identify and address the challenges faced by providers in these pivotal health care settings.

A survey of our members conducted by the committee revealed their dedication to people who seek care at FQHCs.

- 82% choose to work there because of the people they serve and find patients the most rewarding part of their work.
- FQHC clinicians are concerned about burnout (63%).
- The good news is that 77 percent are interested in sharing best practices and biggest challenges with others. This information can shape this group's work in 2017.

The Medical Home provides team-based care in one place: Family medicine practices are innovators in sharing medical and behavioral health under the same roof with a team-based care model. Primary care practices can play an increasingly important role in helping patients address their mental health issues by integrating mental and behavioral health care. Using this approach, primary care teams and behavioral health specialists work side-by-side, sharing patient medical records, treatment plans and overall care management. Tobacco Use Reduction: IAFP works to pass sound tobacco legislation, increase awareness of cessation services and provide practical resources to primary care physicians, health professionals and patients to reduce tobacco use in all categories across the age spectrum. In 2016, we again participated in the Nobody Quits Like Chicagoland awareness week, including hosting a provider webinar on smoking cessation strategies for low-income populations. IAFP members teach Tar Wars tobacco prevention in their local schools. The curriculum continues to evolve, like the tobacco and nicotine industry, with new information on smokeless tobacco, and e-cigarettes.


Opioid Prescribing and Pain Management: Family physicians find themselves at the crux of pain management, balancing care of people who have chronic pain with the challenges of managing opioid misuse and abuse. Together, AAFP and IAFP offer resources for members to effectively navigate this challenge.



IAFP finished the year with 4,738 members 2694 Active 235 Life 643 residents 1134 students 21 inactive and 11 supporting

The Illinois chapter successfully retained 92.7 percent of our active members in 2016, up from 92.4 percent in 2015.

IAFP's leaders were committed to retaining members. Board members, Membership Committee members and staff reached out to 224 members in danger of being dropped through personal email and phone calls to encourage those members to pay their dues and be reinstated. As a result of their efforts, 44 members that were dropped for non-payment in May 2016 were reinstated. Twenty are new physician members and seven are first year active members. Our chapter's New Physician retention rate for 2016 is 85.8%. In 2015, 84.5% of new physician members renewed their membership.




The Membership and Member Services committee created a plan to encourage new-to-practice physicians to directly participate in IAFP events, with a goal of committing to membership and further involvement. Their **New Physician action plan** included incentives and discounts for first year post-residency members.

- 50% dues reduction in state dues for first year post-residency.
- Provide one free registration to an IAFP live event in the first year after residency. IAFP offers 10 free registrations per event, open only to first year active members. In November 2016, this policy was expanded to allow for any member less than three years out of residency to be eligible for one free registration.
- IAFP provides discounted registration for all new physician members less than seven years post residency, consistent with AAFP discounts.

Member Interest Groups - a new way to connect with IAFP

With women physicians serving as president of IAFP, AAFP and the AAFP Foundation in 2016, IAFP president Alvia Siddiqi, MD launched the **Women in Leadership interest group**, to bring together women members from across the career spectrum. The member interest group provided connections for those wishing to share their leadership experience and those looking for guidance in forging their own career path. The WIL held social events in the Chicago suburbs and in Springfield, then capped off their first year with a CME presentation on supporting family caregivers and a workshop at the IAFP annual meeting in November.



As the Direct Primary Care practice model continues to expand and succeed for AAFP members across the country, IAFP turned to our own Illinois success stories to form the **Direct Primary Care interest group**, chaired by Deborah Chisholm, MD – owner of Chisholm Center for Health, a direct primary care practice in LeRoy, Illinois, a small rural town near Bloomington. IAFP cheered the re-election of one member to the AAFP board of directors and the addition of another. Javette C. Orgain, MD, MPH, FAAFP was re-elected by acclamation for a second term as Speaker of the Congress of Delegates. Earlier in 2016 at the AAFP National Congress of Medical Students, UIC student Lauren Abdul-Majeed was elected as the Student Member of the AAFP board of directors.

In our continued dedication to recruiting the family medicine workforce for our state, IAFP organized the fifth annual Family Medicine Midwest Conference, this time in Indianapolis. Over 100 attendees from Illinois benefitted from this event, including 49 medical students who received scholarship support from the Family Health Foundation of Illinois and generous members and organization donors.

Also in 2016, IAFP moved its annual meeting out of the hotel and into the academic center, at Northern Illinois University's Naperville Campus, with a focused environment for CME, ABFM Knowledge Self-Assessments and committee meetings. The All-Member Assembly showcased the installation of our new board and president, along with the celebration of 17 Fellows of the American Academy of Family Physicians (FAAFP). In a bold move to innovate our governance and embrace the availability of technology, the All-Member Assembly voted to dissolve this once-a-year policy making event, and move to a system to provide members with year-round opportunities to raise issues directly to the board of directors each time they meet. We continue to be grateful for our growing and dedicated membership as we continue our mission to provide quality healthcare to Illinois though the support and education of family physicians. It's an honor to serve you.

Devoted to Advocacy

Government Relations

Advocacy is one of the pillars of IAFP and AAFP's mission in representing our members and their patients. We are recognized as much as an advocacy organization as we are a professional membership association. We take pride in both labels.

2016 Elections and Outlook

In Illinois, Democrats retained the majority in both chambers of the 100th General Assembly. However, the House Democrats lost their supermajority status but the Senate Democrats retained their supermajority by two votes.

Regarding the state budget, "....unchartered waters lay ahead and no one can predict where this will all end." Sadly, this quote from our lobbying firm, Cook-Witter, Inc., summarizes the failure to reach a compromise and enact a state budget in 2015 and 2016. Despite a stopgap budget for six months, the state again operated without a budget on January 1, 2017. Payments to state vendors remained several months behind and the state had no mutually agreed solutions to our future school funding, pension and debt crises.

At the federal level, a Republican Administration and Congress ushered in 2017. AAFP reached out to the new Administration and Congress to reiterate its continued support of the following key objectives:

- the importance of maintaining and expanding affordable health insurance coverage for all;
- the important need for payment reform that supports and sustains family medicine and primary care as foundational to a better health care system;
- the need for attention to the primary care workforce needs of our country and reform to its funding;
- the importance of prevention and wellness, as well as special attention to the social determinants of health and health equity; and
- the need to reduce the administrative and regulatory burden experienced by family physicians in their practices.

Federal Advocacy

- IAFP executive leadership attended the Family Medicine Congressional Conference, which includes meeting with Illinois Congressional delegation and developing relationships while sharing immediate issues of concern and long-standing principles of family medicine.
- We provide ongoing dialogue with Congress in the community, providing feedback on Medicare changes, implementation of MACRA, protection of health care access improvements, and continued calls for changes in reimbursement to recognize the value and work of primary care physicians. Our members and leaders drive advocacy for family medicine GME funding, Teaching Health Centers, and policies to promote scholarship and loan repayment programs to build the workforce in Illinois.
- Direct support of congressional members and candidates via AAFP FamMedPAC gives us a seat at the table. In 2016, IAFP

constituents delivered FamMedPAC contributions to Republicans Rep. Rodney Davis, Rep. Peter Roskam and Rep. John Shimkus, and Democrats Rep. Jan Schakowsky, Rep. Robin Kelly, Rep. Tammy Duckworth (elected to the U.S. Senate) and candidate Raja Krishnamoorthi (elected to the House). During the 2016 election cycle, 66 IAFP members contributed a total of over \$16,000 to FamMedPAC.

State Government Advocacy

IAFP works in concert with Cook Witter, Inc., a professional lobbying firm, for the highest level of knowledge – monitoring healthcare issues that number in the hundreds, opposing bills that go against our family medicine values, and supporting bills that improve practice and the health of the public.

Some of our ongoing priorities include:

- Enforcement and protection of Tobacco-Free Illinois
- Strengthening laws around immunization adherence and parent/caregiver information
- Supporting public health and patient safety legislation
- Advocating for expansion of access to care and quality health care insurance coverage
- Advocating for physician payment and administrative simplification.

IAFP hosts **Spring into Action** (lobby days) in non-election years, which provides members, including students and residents, with advocacy training, updates on the issues and then facilitates personal visits with state legislators and administrators on issues affecting members and their patients. Save the dates and plan to attend May 9, 10 or 11.

Ongoing support and counsel to members looking for advocacy guidance. Our web site www.iafp.com/GR has the information and fact sheets to enable members to communicate credibly and concisely. Staff can help coordinate and prepare our members for personal meetings. IAFP also works with the executive branch through the Medicaid Advisory Committee, Prescription Monitoring Program, Department of Public Health, and numerous other state agencies to ensure that the voices of family physicians and all the patients they care for are included in the discussions.

2016 Highlights

Vaccines for Children (VFC) Issues in Illinois Every provider's goal is to vaccinate children. We have worked tirelessly with partner organizations to accommodate a program change regarding children who have the state's Title XXI [21] and State-Funded All Kids eligibility: Since Oct. 1, neither group can receive vaccines through the federal Vaccines for Children (VFC) program. Our advocacy has included an IAFP co-signed a letter to IDPH, an interview with Crain's Chicago Business and nearly weekly calls with the Illinois Department of Public Health (IDPH), the Illinois Department of Healthcare and Family Services (HFS), and other provider organizations to facilitate discussions to convey the following concerns and alert them to the unintended consequences of this change in policy.

- 1. Timeline and lack of MCO billing/payment system readiness
- 2. Ineffective eligibility system to identify Title 21/state-funded population
- 3. Lack of provider education
- 4. Low HFS fee schedule
- 5. Payment delays/holds to providers
- 6. Public Health issue of access to vaccinations

Cooperation and communication is ongoing. Look to e-news for any updates as we strive to address the above issues.

Contraception Coverage Building on state and federal law, H.B. 5576 clarifies the Affordable Care Act to improve access to the full range of contraceptive options for all individuals with health insurance. **The bill passed both chambers and was signed by the governor in late July.**

Step Therapy – HB 3549 amends the Managed Care Reform and Patients' Rights Act to apply provisions to all health plans licensed in the state, including coverage on the Marketplace Exchange, in accordance to the Affordable Care Act. **The bill passed both chambers and was signed into law.**



Medicaid and Medicaid Managed Care - IAFP continued to advocate on your behalf in addressing complications and complaints with the Illinois Medicaid Managed Care Organizations. IAFP leaders and staff amplified your concerns by participating in meetings and conference calls with the Illinois Department of Healthcare and Family Services and also provided live testimony to the Senate's Medicaid Oversight Committee (you can read that testimony at http://www.iafp.com/medicaid-mco-testimony-040616). You can find links to our activities and resources on our web site at http://www.iafp.com/medicaid-mco-resources. We also surveyed our members in partnership with the Illinois State Medical Society and Illinois Chapter of the American Academy of Pediatrics seeking input to improve Medicaid's ongoing transition to managed care. To that end, the key is ongoing communication with the Department of Healthcare and Family Services and the Medicaid managed care organizations to create an effective system that enables physicians and providers to achieve better outcomes for patients, and provides better experiences of care for providers, patients, and caregivers.

IAFP submitted a statement in support of the Research and Demonstration (Behavioral Health Integration) Section 1115 waiver for Medicaid. This demonstration application builds on Illinois' existing hard work which identified several priorities for its behavioral health transformation efforts, including the need to reduce silos of behavioral health care to enable a more efficient system with greater integration of physical and behavioral health. IAFP's statement reflects the work carried out by the IAFP Clinically Integrated Networks Committee in 2014-15.

At the local level, IAFP members and leaders advocated for two important public health policies. Chicago joined the growing list of cities to restrict sales of tobacco products to age 21 and older. The Chicago ordinance took effect July 1, 2016. Evanston also has a Tobacco 21 law. Meanwhile we continue to advocate for a statewide Tobacco 21 law.

Also in 2016, The Cook County Board of Commissioners enacted a penny-per-ounce tax on sugary drinks to reduce consumption and help lower obesity rates taking a toll on public health. IAFP past president and current AAFP Speaker Javette C. Orgain, MD represented the family medicine viewpoint, providing testimony before the commissioners and also doing several media interviews. IAFP supported a similar sugary beverage tax at the state level through the HEAL Act (Healthy Eating Active Living) and in budget negotiations. The effort remains stalled at the state level.

IAFP Fiscal Affairs

The Finance Committee was chaired by then-Treasurer James Valek, MD and its charge is to ensure the integrity of the fiscal affairs of the Academy, including: overseeing budget development and regular financial reporting. IAFP has an annual audit of its financials and the auditors have not brought any concerns to the Finance committee or Board regarding any aspects being audited. The Academy has an Audit Task Force to review the audit as well as the annual tax return. The Academy Audit was performed by BIK & Co, LLP and the taxes prepared by Manietta, CPA.

IAFP earns its revenue from member dues, meeting sponsorship and registration and education projects. In 2016, nearly 41 percent of IAFP revenue came from membership dues. Other non-dues revenue included meeting sponsorship, print advertising, member services benefits and education projects. About 44 percent of 2016 revenue was from the pharmaceutical industry, mostly in education grants and meeting sponsorship, while 15 percent came from non-pharmaceutical industry companies and organizations.
