## Dear Governor Rauner:

We, the undersigned organizations, urge you to sign House Bill 5576, the Illinois Contraceptive Coverage Act, into law immediately. By expanding access to contraception for privately insured women and men, HB5576 will improve health outcomes and reduce healthcare spending in Illinois by helping women plan for healthy pregnancies when they are ready for them.

While the Affordable Care Act took important steps to increase access to contraception, research lead by EverThrive Illinois and the University of Chicago Section of Family Planning and Contraceptive Research identified significant gaps in access to birth control prescribed by physicians. This session, the General Assembly heard testimony from Lisa Peterson who has been battling with her insurance company to receive coverage without cost sharing for the birth control which she and her physician agree is best for her for almost three years. Lisa is not alone in her fight to access the right birth control and her experience shows how severely insurance practices can restrict access to birth control.

Birth control is one of the most widely used medical services in the United States--99% of sexually active women have used at least one type of birth control in their lifetime. However, choosing the right birth control continues to be a difficult and complicated process in which individuals must balance cost, ease of use, and medical factors, including family history and possible side effects.

There is a well documented body of research which demonstrates that insurance barriers between a person and their prescribed birth control, such as denying coverage of a prescribed method or requiring prior authorization or step therapy, decrease the likelihood that that person uses birth control consistently or correctly. This increases the risk for unintended pregnancies, which can lead to negative health outcomes for women and their newborn children and can create barriers to education, employment and other opportunities with long term health, social, and economic impact.

HB5576 guarantees coverage without cost sharing or utilization controls for all FDA approved contraceptive drugs, devices, and supplies, including voluntary sterilization for women and men. Additionally, it requires insurance companies to cover the dispensing of up to 12 months of birth control at one time, which has been shown to decrease costs for health insurance companies and decrease rates of unintended pregnancy. This is common sense, cost efficient legislation that is a win for women, the insurance industry, and the state alike. For that reason, it is supported by the Illinois Department of Public Health. Furthermore, the Illinois Department of Insurance and Illinois Central Management Services are neutral.

Please sign HB5576 immediately to ensure that all residents of Illinois will have access to the birth control that is right for them.
